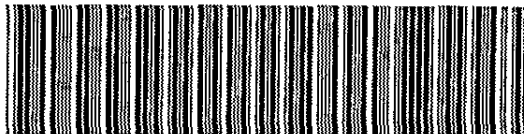

Admission of Additional Members


