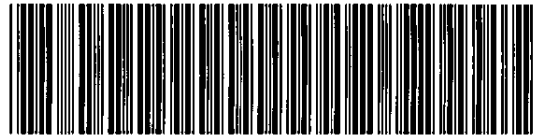


Death, Retirement, Expulsion, Bankruptcy or Dissolution of a Member
