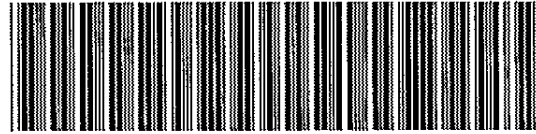

**ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **VIRTUAL ASSISTANCE 4 PROFESSIONALS, LLC** ("Company").

**ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 87 Dogwood Circle, Ocala, Florida 34472 and the mailing address shall be the same.

### **ARTICLE 9 - MANAGEMENT**



whose addresses shall be the same as the principal office of the Company.




