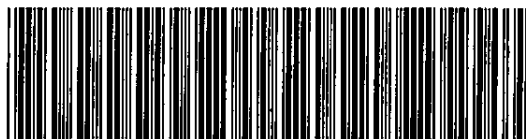

The principal office street and mailing address of this limited liability company is: 4176 Canal Street, Fort Myers, FL 33916.


