ARTICLES OF ORGANIZATION

OF

MARK JOHNSON CUSTOM CARPENTRY, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Mark Johnson Custom Carpentry, L.L.C.

ARTICLE II - ADDRESS
