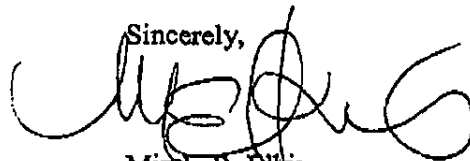

Pursuant to Chapter 608 of the Florida Statutes, LAW OFFICES OF DRAKE OZMENT, LLC, a Florida Limited Liability Company, organized and existing under the laws of the State of Florida, adopts the following Articles of Amendment to its Articles of Organization:

1. Article I of the Articles of Organization is hereby deleted and replaced with the following:

**ARTICLE I**

**Name and Address**

2. Article III of the Articles of Organization is hereby deleted and replaced with the following:

**ARTICLE III**

**Purposes**

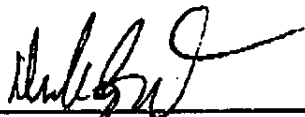
4. The professional services provided by this entity shall be carried out only through officers, managers, employees and agents, each of whom is duly
