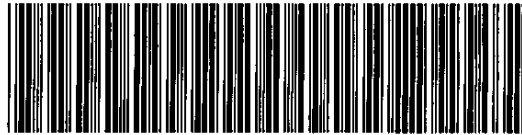

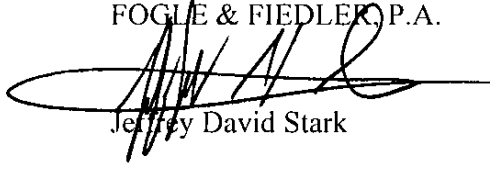

**ARTICLES OF ORGANIZATION OF  
DELAND BARNSTORMERS, LLC**

**Article I**

The name of the limited liability company ("Company") is DELAND BARNSTORMERS, LLC.

**Article II**

The mailing and street address of the Company's principal office is 1151 Carter Rd., DeLand, Florida 32724. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

The power to adopt, alter, amend, or repeal the Regulations or Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.
