

ARTICLES OF ORGANIZATION

of

COMMERCIAL ADVANTAGE GROUP, LLC

We, the undersigned, as organizers of a limited liability company under the Florida Limited Liability Company Act, adopt the following Articles of Organization for such limited liability company:

Article I -- Name
