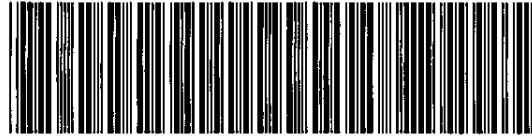

ARTICLE I Name:

The existence of the Company shall begin on the date the undersigned Managing Member s have executed these Articles of Organization.




