# ARTICLES OF ORGANIZATION OF S.C.B. DEVELOPMENT, L.L.C.

SECRETARY OF SEL

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I-NAME

The name of the limited liability company shall be S.C.B. Development, L.L.C. ("Company). The principal place of business of the Company in Florida shall be 2505 DeSoto Blvd., Coral Gables, Fl. 33134.

#### ARTICLE II-PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall be dissolved upon the death, retirement, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members.
