The principal address, mailing address and street address of the company shall be: 2825 SW 2<sup>ND</sup> Avenue, Miami, Florida 33129.

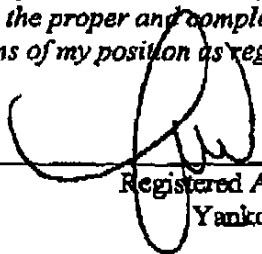
**ARTICLE III -- DURATION**

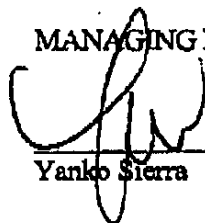
