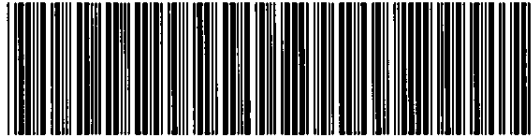

Article Three Principal Office

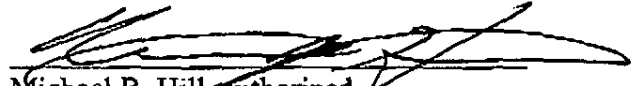

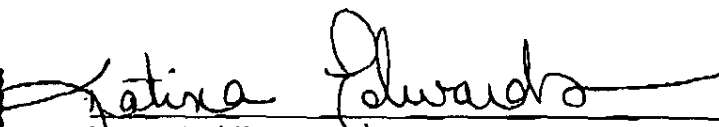

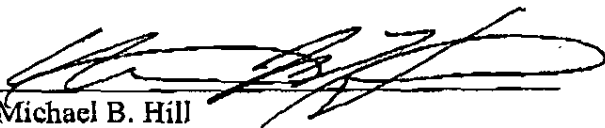
