ARTICLES OF ORGANIZATION

OF

REGENCY PARK, LLC

The undersigned, for the purpose of forming a limited liability company under the Florien Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Regency Park, LLC (the "Company").

The street address of the principal office of the Company in Florida shall be 1409 Kingsley

Avenue, Building 2, Orange Park, Florida 32073, and the mailing address of the Company in Florida shall be P.O. Box 2426, Orange Park, Florida 32067.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE III

REGISTERED OFFICE AND AGENT

The name and street address of the registered agent in the State of Florida are: Mary A. Robison, One Independent Drive, Suite 2000, Jacksonville, Florida 32202.

ARTICLE IV

ADMISSION OF MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

ARTICLE V

TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining member. The Company shall be terminated and dissolved upon the consent of all of the members.

ARTICLE VI

MEMBERS

David J. Muyres, Robert van Winkel and Charles F. Drayton shall be the initial members of the Company.

ARTICLE VII

MANAGEMENT :

The Company shall be managed by one or more members and is, therefore, a member-managed limited liability company. The managing members shall be elected in the manner set forth in the Operating Agreement of the Company. The managing members shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating to Agreement. The initial managing member of the Company is David J. Muyres.

ARTICLE VIII

DURATION

The Company shall exist perpetually. Corporate existence shall commence on the date these Articles of Organization are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, corporate existence shall commence upon filing by the Department of State.
