# ARTICLES OF ORGANIZATION OF ST. JOHNS FOREST GROUP, LLC

The undersigned, for the purpose of forming a limited liability company for profit under the laws of Florida, adopts the following Articles of Organization:

#### Article I Name

Section 1.1. Name. The name of this limited liability company shall be ST. JOHNS FOREST GROUP, LLC.
