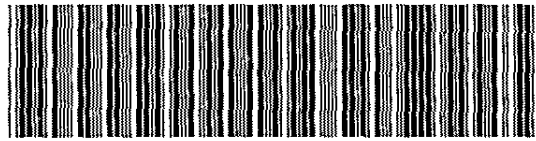



**Article I. Name:** The name of the Limited Liability Company is **V BROWN ENTERPRISES, LLC**.




