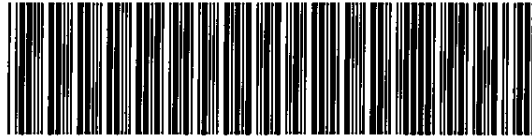



**ARTICLES OF ORGANIZATION OF
AUTOMOBILITY, L.L.C.**

ARTICLE I

Name

Continuation of Business




