

**ARTICLES OF ORGANIZATION
OF
KIRCHMAN GROVES, LLC**

The undersigned, a duly authorized representative of a member of this limited liability company, adopts these articles of organization to form a limited liability company under Chapter 608, Florida Statutes, the Florida Limited Liability Company Act.

ARTICLE I. NAME

The name of this limited liability company is **KIRCHMAN GROVES, LLC** (the "Company").

ARTICLE II. PRINCIPAL OFFICE

The principal office and street address of the Company is 510 N. Pennsylvania Ave., Winter Park, FL 32789.

ARTICLE III. REGISTERED OFFICE AND AGENT

Without limiting the generality or the effect of the foregoing, the Company may enter into one or more agreements with any person which provide for indemnification greater or different than that provided by this Article IV. Any amendment, modification or repeal of this Article IV shall not adversely affect any right or protection existing hereunder at the time of such amendment, modification or repeal.
