

**Articles of Organization**

(A Member-Managed Florida Professional Limited Liability Company)

ARTICLE I

Name and Duration

The name of this Limited Liability Company is THE HENRY LAW FIRM, PLC (hereinafter referred to as the "Company"). The duration of this Company is perpetual. The effective date upon which this Company shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office and Mailing Address

Management By Members

The management of the Company shall be reserved to the Members, unless otherwise provided in the Operating Agreement or other governing instrument. LaMya A. The Members may elect, by a majority in interest of the Members, additional managing members of the Company to conduct the business affairs of the Company, all in accordance with the Operating Agreement.

ARTICLE VII
