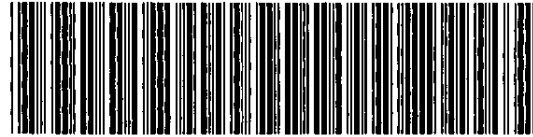


**ARTICLES OF REVOCATION OF DISSOLUTION

4. The revocation of dissolution was authorized in the same manner as the dissolution on May 22, 2012.


