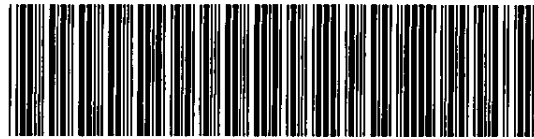

**ARTICLES OF ORGANIZATION OF
DELTONA STETSON FLORAL, LLC**

Article I

The name of the limited liability company ("Company") is DELTONA STETSON FLORAL, LLC.

Article II

The street address of the Company's principal office is 2051 Saxon Boulevard, Deltona, Florida 32725 and the Company's mailing address is 826 E. Normandy Boulevard, Deltona, Florida 32725. The member shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.


