2. **ARTICLE IV - MANAGEMENT** is deleted in its entirety and replaced with the following:

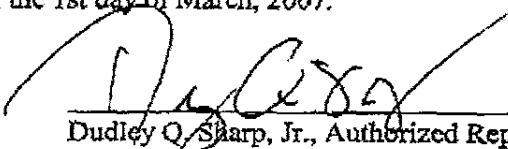
