The name of the Company is PARC Splashtown, LLC.

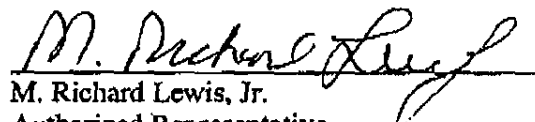

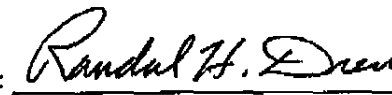
