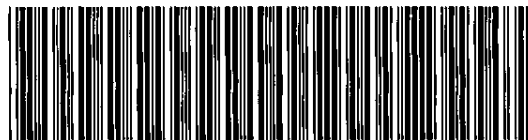

**ARTICLES OF ORGANIZATION
OF

a Florida Professional Service Limited Liability Company**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name:

The name of the limited liability company (hereinafter referred to as the "Company") is Urgent Care Medical Associates, P.L.

ARTICLE II - Address:

ARTICLE VII - Existence:

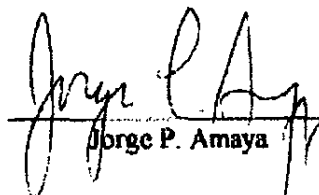
The existence of the Company shall begin on the date the undersigned Managing Member has executed these Articles of Organization.
