Pursuant to Section 608.4115, F.S., this document is being submitted within the required thirty (30) business days to correct the attached Articles of Organization.

1. The name of the limited liability company is PROMENADE GRILL AND WINGS, LLC (the "Company").
2. The Articles of Organization were filed on February 21, 2007 and assigned document number L07000019853.
3. The Articles of Organization contain the following incorrect statements:

- (a) In Article II, the street address of the Company was written as: 2202 Midport Road, Port St. Lucie, FL 33452. Both the street name and zip code are incorrect because the preparer of the Articles of Organization did not know that the name of the road had changed and mistyped the zip code. The correct street address is: 2202 SE Veterans Memorial Parkway, Port St. Lucie, FL 34952-4873.
- (b) In Article IV, the corporate indicator "Inc." at the end of the Registered Agent's name was mistyped. The correct corporate indicator is "Corporation." The full correct name of the Registered Agent is: One Casa Corporation.
- (c) In Article V, the preparer believed that all members of the Company were to be listed in the Articles of Organization and did not understand what the abbreviations of the titles meant. Jeffrey Arrigoni, a member of the Company, was listed as a manager of the Company. As only managers and managing members are to be listed in the Articles of Organization and Mr. Arrigoni holds neither position, his name and address should be deleted entirely from Article V of the Articles of Organization.

The corporate indicator "Inc." at the end of the managing member's name was mistyped. The correct corporate indicator is "Corporation." The full correct name of the managing member is: One Casa Corporation.
