**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The name of this limited liability company is H.T. DEVELOPMENT, LLC, a Florida limited liability company (the "Company").

**ARTICLE II
DURATION**


ARTICLE IX
