

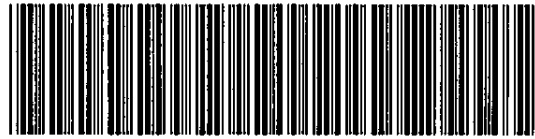

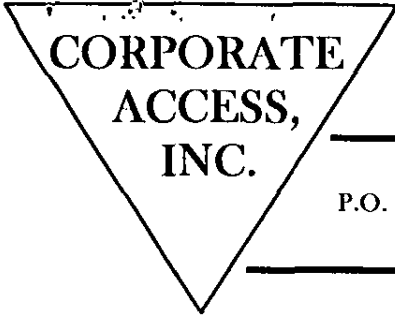

ARTICLE II — Address:




