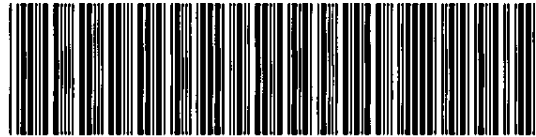

FOURTH: The mailing address and street address of the principal office of the Limited Liability Company is 8501 Padova Ct., Orlando, FL 32836.




