**AMENDED ARTICLES OF ORGANIZATION
OF

Pursuant to Chapter 608, *Florida Statutes*, Vue Night Club, LLC, a Florida limited liability company, adopts the following amendment to its Articles of Organization.

FIRST: The Members wish to delete Article 5, Management, and substitute in lieu thereof the following:

**Article 5
Management**


The Company shall be managed by two managers. The Managers shall be elected as provided in the Operating Agreement.
