**ARTICLES OF ORGANIZATION  
OF  
ACE EQUIPMENT, LLC**

1. Name. The name of this limited liability company is **ACE EQUIPMENT, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. Duration. The Company shall exist from the date of filing of these Articles of Organization with the Florida Secretary of State, and the Company's existence shall be perpetual.

3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.


4. Place of Principal Office. The street address of the Company's principal office is 445 Hancock Lake Road, Brooksville, Florida 34602, and the mailing address of the Company is Post Office Box 20552, Tampa, Florida 33622.

5. Registered Agent and Office. The name of the initial registered agent of the Company is F & L Corp. The street address of the initial registered agent of the Company is One Independent Drive, Suite 1300, Jacksonville, Florida 32202.

6. Management of the Company. The management of the Company shall be vested in the managers of the Company. The initial manager of the Company is Vince Austin, whose address is Post Office Box 20552, Tampa, Florida 33622.

7. Operating Agreement. The members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
