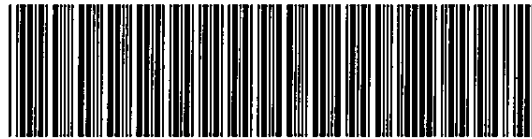



ARTICLE V
