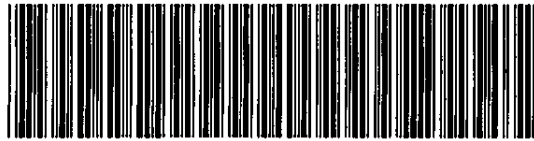

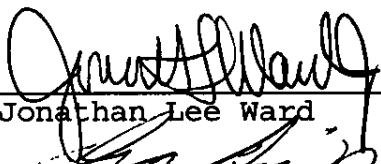
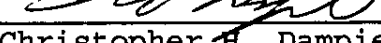
ARTICLE V

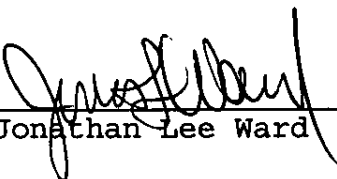
