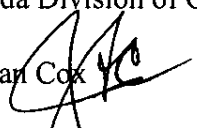

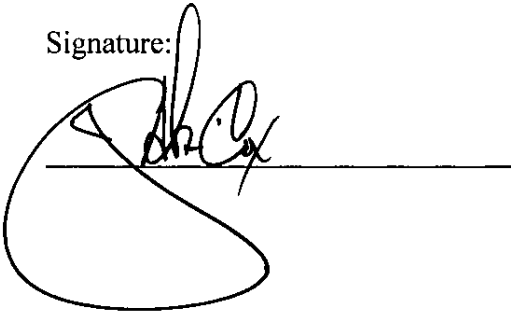

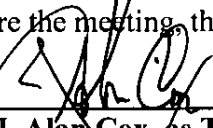
**MINUTES OF SPECIAL MEETING OF THE

The purpose of the meeting was to approve the dissolution of the Company. After discussion, it was unanimously

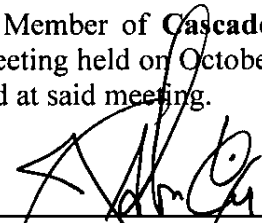
