**ARTICLES OF ORGANIZATION  
OF  
INFINITE WINDOWS, LLC**

The undersigned, being a duly authorized representative of the members, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I**

**NAME**

The name of the limited liability company is INFINITE WINDOWS, LLC (the "Company").

**ARTICLE II**

**ADDRESS**

The principal office and mailing address of the Company is: 2416 N.W. 16<sup>th</sup> Road, No. 808, Miami, Florida 33126.

**ARTICLE III**

**REGISTERED AGENT AND OFFICE**

**DURATION AND CONTINUATION**

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated (i) in accordance with the Company's Operating Agreement, or (ii) by the written agreement of a majority of ownership interest.

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

The Managers shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. The Managers shall serve in such capacity until their successor(s) are duly elected and qualified.

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Members of the Company in the manner set forth in the Operating Agreement of the Company.
