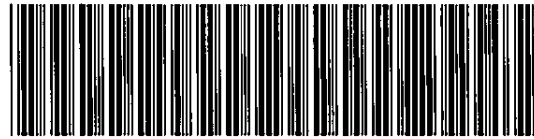

The name of the Limited Liability Company is 1 @ Block 55, LLC (the "Company").




