ARTICLES OF ORGANIZATION OF PORTMAN LAUDERDALE HARBORS, LLC

These Articles of Organization are made and acknowledged by the undersigned Members for the purpose of creating a domestic limited liability company in accordance with §608.407 Florida Statutes.

ARTICLE I

The corporate name of the limited liability company shall be PORTMAN LAUDERDALE HARBORS, LLC The limited liability company is organized to engage in any lawful act or activity for which a limited liability company may be organized under the provisions of the Florida Limited Liability Company Act set forth in Chapter 608 Florida Statutes.
