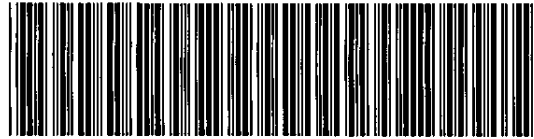

ARTICLES OF ORGANIZATION

OF

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as a Member of Kat Man Tay, LLC (hereinafter the "Limited Liability Company"), does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

In the event that the members of the Limited Liability Company elect or appoint one or more members to serve as managing-members of the Limited Liability Company, the remaining members of the Limited Liability Company who were not so elected or appointed shall have no power or authority to bind the Limited Liability Company in any way, pledge its credit or to render it liable for any purpose unless such member has been authorized by the managing-members in writing to act as an agent of the Limited Liability Company in connection with such transaction.

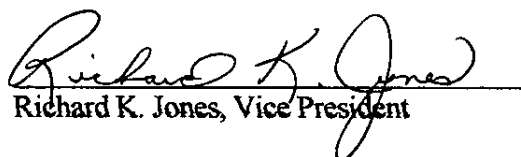
CERTIFICATE OF DESIGNATION OF
