ARTICLES OF ORGANIZATION

OF

ARTICLE I. NAME

The name of the limited liability company is Law Office of Clayton B. Gordon, P.L. (the "Company").

(d) To do everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Organization or any amendment thereof, necessary or incidental to the protection and benefit of the Company, and in general, either alone or in association with other corporations, limited liability companies, firms or individuals, to carry on any lawful activity necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects for which this Company is formed, and to have all the powers conferred upon this Company by the laws of the State of Florida or of any other state or country and not prohibited by the Act.

The foregoing paragraphs shall be construed as enumerating both the objects and the purposes of the Company; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Company otherwise permitted by law.

ARTICLE V. TERM OF EXISTENCE

This limited liability company is to exist perpetually.
