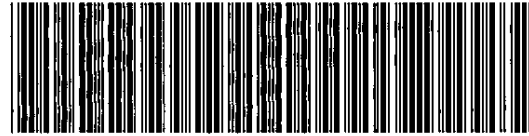

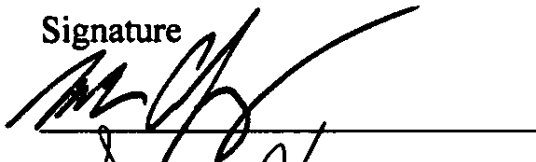

4. The revocation of dissolution was authorized in the same manner as the dissolution on July 20, 2010.

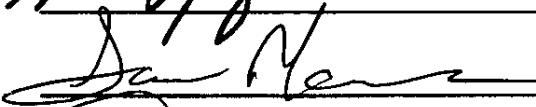
