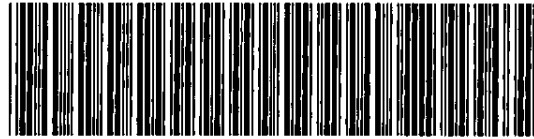



Know all men by these presents that there is hereby created a Limited Liability Company pursuant to Chapter 608, Florida Statutes, and these articles and agreements:

ARTICLE I

ARTICLE VII


The powers set forth in Section 608.404 for the Company may be executed for the Company by Robert L. Pender, whose signature shall be affixed to any document as appropriate.


