Limited Liability Corporation Articles of Organization Of THE Des RUISSEAUX GROUP, LLC.



We, the undersigned, who intend to form and create a Limited Liability Company, PURSUANT TO THE Statutes of the State of Florida, do hereby state and certify the following:

- 1. The name of the Liability Company shall be THE Des RUISSEAUX GROUP, LIMITED LIABILITY COMPANY.
- 2. The registered office of the company is located at 11760 Berry Drive, City of Cooper City, State of Florida. Its registered agent is Reynold C. Des Ruisseaux for service of process.
- 3. The principal place of business of the Company is located at 11760 Berry Drive, City of Cooper City, State of Florida.
- 4. The purpose for which the company is formed is to engage in any lawful acts or activities for which limited liability companies may be formed under laws of the above named State.
- 5. The company shall have a duration of 30 years and it shall dissolve at the end of said time frame.

The termination of any action, suit, or proceeding by judgment, order, settlement, conviction, or plea of nolo contendere, or its equivalent shall not, of itself, create a presumption that the person did not act in good faith and in a manner which he or she reasonably believed to be in, or at least not opposed to, the best interest of the company.
