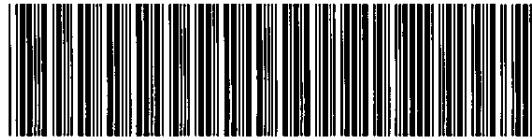


Article IV - Management
