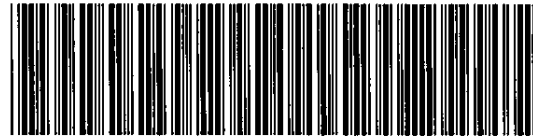

**NAME**


