**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
UCT FORESTRY GROUP, LLC**

Pursuant to the Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes, the undersigned desiring to amend and restate the articles of organization of UCT FORESTRY GROUP, LLC, a limited liability company (the "Company") duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on February 27, 2007, and assigned document number L07000022342. The undersigned confirms that these Amended and Restated Articles of Organization were unanimously adopted by the Sole Member of the Company by a Written Consent of the Meeting of the Sole Member of the Company on June 1st, 2010. The following Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

ARTICLE I

NAME

The name of the limited liability company is UCT FORESTRY GROUP, LLC (the "Company").

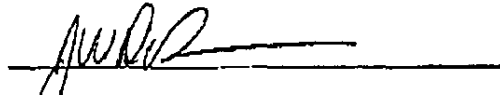
ARTICLE V**MANAGEMENT**
