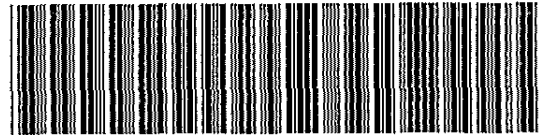

**ARTICLES OF ORGANIZATION



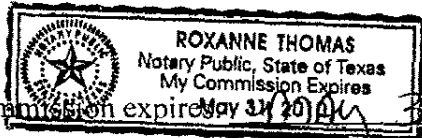
