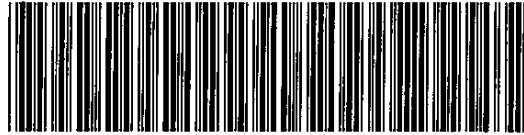


FIRST: The Articles of Organization were filed on February 28, 2007, and assigned document number L07000022496.
