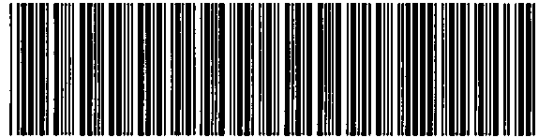

ARTICLES OF ORGANIZATION OF ACKERMANN INVESTMENTS, LIMITED
LIABILITY COMPANY

The undersigned, acting as organizers of ACKERMANN INVESTMENTS, LIMITED LIABILITY COMPANY, under the State of Florida Limited Liability Company Act, adopt the following Articles of Organization:

I. NAME OF COMPANY

The name of the limited liability company (LLC) is ACKERMANN INVESTMENTS, L.L.C. (Company).

II. PERIOD OF DURATION

The period of duration is perpetual from the date of filing of these Articles of Organization with the State of Florida Secretary of State, unless the Company is sooner dissolved.

III. PURPOSE

The Company is organized for any legal and lawful purpose pursuant to the State of Florida Limited Liability Company Act, except for the purpose of banking or insurance.

IV. REGISTERED OFFICE AND AGENT

The Company's principal place of business is in Tampa is at the address of its initial registered agent, and the name and address of the initial registered agent at that address is: Melissa S. Ackermann, Cushman & Wakefield, Tampa City Center, Suite 3600, Tampa, Florida 33602.

V. MEMBERS

There is one member, Melissa S. Ackermann. The total amount of cash contributed by check or wired or certified funds by the Member is the organizational costs. The Member has not made any additional contributions, but may agree to do so in the future.

VI. ADDITIONAL MEMBERS

The members reserve the right to admit additional members on the unanimous agreement of the members as to the admission of, and the consideration to be paid by, such new members, and subject to the terms and conditions of the Company's Operating Agreement.

VII. OPERATING AGREEMENT

The Operating Agreement of the Company will be executed by each member of the Company and will set forth all provisions for the affairs of the Company and the conduct of its business to the extent that such provisions are not inconsistent with law or these Articles.

VIII. CONTINUATION UPON WITHDRAWAL OF MEMBER

The members will have the right to continue the Company on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or occurrence of any event which terminates the continued membership of a member in the Company (collectively, "Withdrawal"), as long as there are at least two remaining members, and the remaining members agree to continue the Company by unanimous written consent within 90 days after the Withdrawal of a member, as set forth in the Operating Agreement of the Company.

IX. LIABILITIES OF MEMBERS AND MANAGERS

Members and managers of the Company are not liable under a judgment, decree or order of a court, or in any other manner, for a debt, obligation or liability of the Company.

X. MANAGERS

The manager may be removed and replaced by the Members, as provided in the Operating Agreement.
