ARTICLES OF ORGANIZATION OF ACKERMANN INVESTMENTS, LIMUTA

The undersigned, acting as organizers of ACKERMANN INVESTMENTS, LIMITED LIABILITY COMPANY, under the State of Florida Limited Liability Company Act, adopt the following Articles of Organization:

I. NAME OF COMPANY
