ARTICLES OF ORGANIZATION of Vin IAY RAY, LLC

These Articles of Organization are adopted for the purpose of forming a limited liability company under the laws of the State of Florida, to be filed with the Elorida Department of State, as follows:

ARTICLE ONE: NAME
