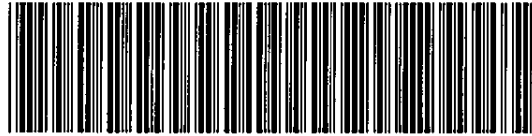

1. **NAME.**

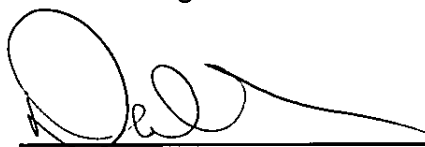
