ARTICLES OF ORGANIZATION OF THE TRUSTED ADVOCATE, LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for The Trusted Advocate, LLC (the "Company"):
